Philosophy

Some students are not successful in a traditional classroom setting. The curriculum, daily schedule, and classroom arrangement of the Aledo Learning Center are designed to develop the personal responsibility and self-discipline necessary to earn a high school diploma. Students who are prepared to work hard can accelerate progress toward that goal.

Expectations for Students

The faculty and staff of the Aledo Learning Center expect each student to be **responsible** for the following:

- 1. Personal behavior
- 2. Adequate progress in each subject
- 3. Regular school attendance
- 4. Respect for faculty and fellow students

Application Procedures

Any student desiring to attend the Aledo Learning Center must make application through the administration at Aledo High School. A campus administrator or counselor can assist the student in completing the application forms and necessary documents for an entrance interview. Applications are reviewed at the end of every nine week grading cycle.

After all materials are received, the student will have an orientation meeting with the Principal of the Aledo Learning Center. A Parent/Guardian must attend the orientation with the student. This meeting can take place over the phone, in person or via WebEx.

The applicant and the parents/guardian should realize the Aledo Learning Center is an academic alternative high school serving grades 9 through 12. It is important that all parties in the application process know that attending the Aledo Learning Center is a privilege. If the student chooses not to attend school and not be productive, they will be returned to Aledo High School so that other students may attend in their place. Students must be willing to commit themselves to regular school attendance and they must accept the responsibility for their own academic and behavioral progress.

Student Eligibility

Students who are in grades 9 through 12 are eligible to attend the Aledo Learning Center. Ninth grade students who are parenting teens may make application as necessary. Other ninth grade students should be at least a second semester ninth grader and 15 years of age as of September 1, of the school year for which they are making application. It is the philosophy of the Aledo Learning Center that a student should experience high school before coming to the Aledo Learning Center.

The Aledo Learning Center is for students in grades 9-12 ages 15 to 21 years who:

- 1) are behind one or more grade levels
- 2) are not expected to graduate within four years of the date the student begins ninth grade
- 3) are pregnant or a parent

Each student attending the Aledo Learning Center should realize that he/she has made application to attend this school. The student has been chosen and is occupying a valuable spot that is available to only a limited number of students at a time. Each student should recognize that it is a unique opportunity and a privilege to be a student at the Aledo Learning Center. A student entering this school should come to school knowing that regardless of their previous school problems they will be accepted and given the opportunity to overcome whatever difficulties they may have experienced in the past. However, the student must be willing to let the staff assist them with their problems and they must be willing to change behaviors that have kept them from succeeding in previous school settings.

Attendance Policies

A student's success at the Aledo Learning Center hinges on students being prompt and regular in their attendance. The entire process of education requires a regular continuity of instruction, classroom participation, learning experience, and study in order to reach the goal of maximum educational benefits for each student. The regular contact of the pupil with one another in the classroom and their participation in well-planned instructional activities under the direction of a competent teacher are vital to this purpose.

There is a direct relationship between poor attendance and academic failure. Students with good attendance records generally achieve higher grades, enjoy school more, and are more employable after leaving high school. Thus, all students are expected to attend school regularly and to be on time to classes in order to derive maximum benefit from the instructional program and to develop habits of punctuality, self-discipline and responsibility.

The Aledo Learning Center follows the Aledo I.S.D. school calendar for the beginning and ending of school, holidays, vacations, and staff professional learning days.

Behavior Management

The Aledo I.S.D. Student Code of Conduct is the guide for behavior management. When misbehaviors occur the interventions and consequences found in the Student Code of Conduct will be used. Upon enrollment to the ALC, students and guardians will review and sign the Student Rights & Expectations document. Students will also adhere to all campus wide behavior expectations.

Celebrations

Campus and classroom celebrations may occur periodically throughout the school year to celebrate student successes.

Cell Phones

ALC students are allowed to have their personal cell phones on campus. However, student cell phones along with Bluetooth devices will be kept in a designated area during class time. Students may view their cell phones before/after school, in between classes and during lunch. Cell phones must be silenced and placed in designated location before the tardy bell rings. Students that cannot abide by this rule will have their cell phone locked up for the remainder of the school day. After the first offense, cell phones will be taken up and students must pay a \$15 fee before the phone is returned.

Class Ranking

Courses earned while enrolled in the Aledo Learning Center will not be included in a class ranking. Students who attend Aledo Learning Center will receive a regular high school diploma and will not be considered for Honor Standing as a graduate.

Dress Code

The Aledo ISD dress standards are established to prevent disruption and support the safety of all students, staff and campus visitors. All students are expected to dress in a respectful manner within the acceptable standards of the educational community and in such a manner as to contribute to the academic atmosphere. Specifically, the dress standards are intended to teach students a skill that is required for success in future employment.

Aledo ISD expects that all students will dress in a way that is appropriate for the school day and for any school-sponsored event.

Our student dress standards are designed to accomplish the following goals:

- Maintain a safe learning environment in classes where protective or supportive clothing is needed, such as chemistry/biology, dance or PE.
- Prevent students from wearing clothing or accessories that denote, suggest, display or reference alcohol, drugs or related paraphernalia, or other illegal conduct or activities.
- Prevent students from wearing clothing or accessories that will interfere with the operation of the school, disrupt the educational process, invade the rights of others or create a reasonably foreseeable risk of such interference or invasion of rights.
- Prevent students from wearing clothing or accessories that reasonably can be construed as being or including content that is profane, racist, lewd, vulgar or obscene, or that reasonably can be construed as containing fighting words, speech that incites others to imminent lawless action, defamatory speech or threats to others.

Students shall come to school looking clean, neat and ready to learn. Furthermore, to support proper hygiene on campus and maintain an environment conducive to learning, blankets and pillows, whether "worn" or carried, are prohibited on campus unless otherwise directed by the school staff.

Students Must Wear:

- Clothing that covers all private body parts at all times.
 - Undergarments and clothing including both a shirt with pants, dress, skirt, or the equivalent.
 - Shorts, including athletic shorts, must extend beyond the buttocks and pelvic region at all times.
- Shoes at all times.
- Clothing suitable for all scheduled classroom activities including physical education, science labs and CTE courses, and other activities where unique hazards exist.

Students May Wear:

- Religious headwear
- Hooded sweatshirts
 - Hoods cannot be worn while in the building.
- Fitted pants (including leggings, joggers, and "skinny jeans")
- Sweatpants, shorts, skirts, dresses, pants
- Ripped jeans if undergarments and buttocks are not exposed

- Tank tops, excluding those with spaghetti straps
- Athletic attire
- Clothing that does not violate the guidelines in the "May Not Wear" section below.

Students May Not Wear:

- Strapless, backless, halter, bare-midriff, or spaghetti strap shirts/blouses/dresses.
- Clothing that reveals undergarments.
- Pajamas or house shoes/slippers.
- Hats, hoods, caps, visors or similar hat-like apparel (unless approved by administration).
- Costume apparel or accessories.
- Clothing displaying violent language or images.
- Clothing with images or language depicting or representing drugs, alcohol (or any illegal item or activity), hate speech, profanity or pornography.
- Clothing with images or language that creates a hostile or intimidating environment based on any protected class or consistently marginalized groups.
- Accessories that could be considered dangerous or could be used as a weapon.
- Any item that obscures the face (except as a religious observance or as required by the district to mitigate health risks associated with the spread of communicable disease).

For special events, defined by campus administration, specific dress requirements may be set. When there is a question on the dress or appearance of a student, the building administrator and school staff will use their discretion concerning the standards of dress.

Solutions to Address Aledo ISD dress standards:

If a student is not following the dress standards, the administrator/staff member should address the student in private to come up with a solution using the following guidelines:

- Students are expected to be in compliance with the dress standards during the instructional day.
- Students will be given the option of removing articles and accessories that do not conform to the standards of dress.
- Students will be asked to put on their own alternative clothing, if already available at school, to be dressed more to the standards for the remainder of the day.
- Students will be provided with temporary school clothing to be dressed more to standards for the remainder of the day (when available).
- If necessary, students' parents/guardians may be called during the school day to bring alternative clothing for the student to wear for the remainder of the school day.
- Students will not be allowed to leave campus for the purpose of changing clothes.

If a student refuses to accept the solutions provided above, he or she will be deemed as noncompliant and will be addressed in accordance with the Aledo ISD Student Code of Conduct.

The school administrators may make appropriate adjustments in the dress standards to fit the unique needs of a campus or student needs, and shall employ appropriate disciplinary procedures to carry out and enforce this policy.

Report Cards, Progress Reports, and Conferences

Progress reports will be emailed to parents weekly. The standard of mastery for The Aledo Learning Center courses is 80%. A grade of 80 must be obtained in order to receive credit for a class. If the student is not making satisfactory progress in completion of courses, a student conference will be requested to discuss strategies to improve progress. Student Identification Badges

IDENTIFICATION (ID) BADGES REQUIRED FOR ALL 6TH-12TH GRADE STUDENTS

The Aledo Independent School District wants its students, staff, and parents to know the priority we place on safety and security. Proactive measures include extensive emergency operations plans, regularly scheduled safety drills, video camera monitoring throughout the district, controlled access to all facilities, and School-Based Law Enforcement at all district campuses. Aledo ISD requires all 6th - 12th grade students to wear ID badges whenever present on school property during the school day.

Each 6th-12th grade student will receive a photo ID badge and a lanyard at the beginning of each school year. Throughout the school day, students will be required to clearly display their ID around the neck with school-issued lanyard. Students will be required to wear the lanyard and ID at all times unless the lanyard and ID pose a potential safety concern for a class activity, such as PE/athletics or in a science lab. Teachers will instruct students to remove their lanyard and ID if there is a safety concern for the class activity.

If a student loses the ID, a replacement must be purchased promptly from the designated school office/location. Displayed badges will help to ensure that the student is currently enrolled in the Aledo ISD.

Requirements:

- ID badges must be hung on the school-issued lanyard around the neck during the entire school day.
- ID badges must be work with the picture facing out.
- ID badges must not be defaced or altered in any way.
- ID badges much be worn on top of the outermost layer of clothing.

Failure to follow the requirements above may be considered a violation of the Student Code of Conduct. Potential consequences are as follows:

- Verbal Reminder/Issuance of Temporary ID Badge
- Issuance of Temporary ID Badge/Lunch Detention
- Issuance of Temporary ID Badge/After School Detention with Parent Contact
- Office Referral/ISS

New ID cards and lanyards will be issued each school year. The first ID card and lanyard each year will be provided at no cost. Lost or replacement cards will cost \$5 at AMS and \$10 at DNGC, ALC and AHS. Replacement Aledo ISD lanyards can be replaced at a cost of \$2 each.
