The Tarrant County Elections Administrator or his designee shall break the seals and do the following:

- a. Count the number of paper ballots in the case/box to compare to the number of votes reported as cast on election night for each of the nine locations. If this number does not exceed what the relevant scanner reported for each location, then the EA will seal the case and not proceed to the next step.
- b. If the number of ballots in a case/box is greater than the number reported by the relevant scanner, the EA shall scan the ballots and add the correct number to the count.

The Tarrant County Elections Administrator or his designee shall take such other action as the Elections Administrator deems necessary to render a correct count of the votes, to perform the duties required by law, and to provide continuing security of the voted ballots and other election records.

Any interested person may observe the opening of the transfer cases/boxes. The handling and counting of any ballots and the handling of election records, once the cases/boxes are opened, shall be as provided by law.
